A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CROWLEY, TEXAS, CANVASSING AND DECLARING THE RESULTS OF THE SEPTEMBER 23, 2023 SPECIAL ELECTION FOR THE PURPOSE OF ELECTING A CITY COUNCIL MEMBER TO PLACE 5 FOR THE REMAINDER OF THE TERM ENDING MAY 2026; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Crowley (the "City") is a home rule city acting under its charter adopted by the electorate pursuant to Article XI, Section 5, of the Texas Constitution and Chapter 9 of the Local Government Code; and

WHEREAS, on September 23, 2023, the City's Special Election to fill a vacancy was held in accordance with the Election Code for the purpose of electing a member to City Council Place 5 for the remainder of the term ending May 2026; and

WHEREAS, state law requires that the governing body of the City of Crowley canvass all elections.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CROWLEY, TEXAS:
