- Line-up for the parade kicks off at 4:30 PM at 512 Peach St. (Former CISD building).
- Parade officially starts at 6 PM
- All participants are required to adorn their entries with Christmas Lights.
- Please refrain from throwing candy from floats. Walkers accompanying floats are permitted to distribute candy to the spectators, ensuring they stay with their respective floats.
- Get creative, embrace the festive spirit, and enjoy the decorating process! Prizes will be given for 1st, 2nd, and 3rd place. The awards ceremony will take place on stage at the plaza after the parade.
- Registration must be submitted no later than 12 noon on December 1st Email entry forms to jhepler@ci.crowley.tx.us or drop off at City Hall or Crowley Rec Center. You can also mail them to City of Crowley, 201 E Main Street, Crowley, Tx 76036, Attn: Julie Hepler.
- The Christmas in Crowley Lighted Parade is a non-political event. Only current office holders are eligible to participate. Entries attempting to use the parade for political purposes will be disgualified.
- The parade route STARTS at 512 Peach St and ENDS on Mission Street. Parade will travel through the roundabout and exit Roberts Street and then Left on to East Mission to disperse.
- Note: There should be no Santa Clauses on individual floats as Santa will be on a city $\dot{\mathbf{v}}$ float. Including Santa on your float will result in removal.
