MINUTES OF THE CRIME CONTROL AND PREVENTION DISTRICT, REGULAR SESSION HELD on December 5, 2019. The Board of Directors (the "Board") of the Crowley Crime Control and Prevention District convened in Regular Session at 6:00 p.m., in the Crowley City Hall, City Council Chambers, 201 East Main St., Crowley, Texas.

CALL TO ORDER/ ROLL CALL

President Christine Gilbreath called the Regular Session to order at 6:00 p.m. Secretary Carol Konhauser called roll and noted a quorum was present.

PUBLIC HEARING

1. Hold a public hearing and request the Crowley Crime Control and Prevention District (CCPD) Board of Directors to consider ordering an election for May 2, 2020 to continue the CCPD for a period of time allowed by law (5, 10, 15 or 20 years).

President Christine Gilbreath opened the public hearing at 6:00 p.m. for anyone to speak either in favor of or in opposition of. No one came forward to speak and President Gilbreath closed the public hearing at 6:01.

BUSINESS

1. Discuss and consider approval of the minutes of the Crime Control and Prevention District Board of Directors meeting held on Dec 5, 2019.

Member Jesse Johnson made the motion to approve the minutes as presented, second by Member Tina Pace, the Board voted unanimously to approve the minutes as presented. Motion carried 7-0.

2. Discuss and consider approval of Order No 2019-001, calling a Referendum to determine whether the voters desire to continue the Crime Control and Prevention District (CCPD) and Sales Tax for the number of years (either 5, 10, 15 or 20 years) as determined by the CCPD Board of Directors and allowed by state law..

Member Billy Davis opened the discussion by suggesting 15 years. Member Jesse Johnson suggested 20 years because he felt that legislatures were going to make changes in the future that would take away the 2.5 cent local sales tax.

City Manager Robert Loftin explained that if the citizens felt 20 years was too long and they voted against the proposition, the City would have to begin the entire process of creating the CCPD from

the beginning. City Attorney Rob Allibon agreed with the City Manager Loftin and stated the City needed to balance their needs and the desires of the citizens.

Member Jesse Johnson made the motion to approve Order No 2019-001 calling a Referendum to determine whether the voters desire to continue the Crime Control and Prevention District and sales tax for 15 years, second by Member Jerry Beck, the CCPD Board of Directors voted unanimously to approve the motion as presented. Motion carried 7-0.

As there was no further business, President Christine Gilbreath adjourned the meeting at 6:14 p.m.

SUBJECT: Discuss and consider approval of Order No 2020-002, postponing the Referendum to determine whether the voters desire to continue the Crime Control and Prevention District (CCPD) and Sales Tax for 15 years from May 2, 2020 to July 14, 2020, pursuant to the Proclamation issued by Governor Gregory Abbott on April 6, 2020.

BACKGROUND/DISCUSSION

The Crowley Crime Control and Prevention District (CCPD) approved Order No 2019-001 calling for a Referendum to be held on May 2, 2020 to determine whether the citizens of Crowley, Texas, desire to continue the Crime Control and Prevention District and to Continue a Crime Control and Prevention District Sales Tax.

Due to the current situation surrounding the COVID-19 epidemic, the Governor issued an executive order authorizing local governmental agencies to move their May 2, 2020 election date to Nov 3, 2020. Unfortunately, the CCPD will expire on Sep 30, 2020, prior to the Nov 3, 2020 election. Therefore, in accordance with Section 41.0011 of the Texas Election Code, the City submitted a request to the Governor asking to hold and Emergency Special Election on July 14, 2020 for the CCPD referendum. The Governor did approve the City's request on April 6, 2020.

The CCPD now has to approve an Order postponing the Referendum and City Council can then adopt a new Ordinance ordering an Emergency Special Election.

FINANCIAL IMPACT

The ballots and data cards were already ordered for the May 2, 2020 election (est cost approximately \$2,500). This Emergency Special Election will be ONLY for the CCPD proposition. We will then have to hold the General Election for places 5 and 6 on November 3, 2020. Estimated cost of this Emergency Special Election is \$8,500.

RECOMMENDATION

Staff recommends approving the Order.

ORDER NO. 2020-002

AN ORDER OF THE BOARD OF DIRECTORS OF THE CROWLEY CRIME CONTROL AND PREVENTION DISTRICT, POSTPONING THE REFERENDUM TO DETERMINE WHETHER THE CITIZENS OF CROWLEY, TEXAS, DESIRE TO CONTINUE THE CRIME CONTROL AND PREVENTION DISTRICT AND TO CONTINUE A CRIME CONTROL AND PREVENTION DISTRICT SALES TAX PURSUANT TO CHAPTER 363 OF THE TEXAS LOCAL GOVERNMENT CODE, FROM MAY 2, 2020 TO JULY 14, 2020, PURSUANT TO THE PROCLAMATION ISSUED BY GOVERNOR GREGORY ABBOTT ON APRIL 6, 2020.

WHEREAS, on December 5, 2019, the Crowley Crime Control and Prevention District Board of Directors approved Order No. 2020-001 calling for a Referendum to be held on May 2, 2020, to determine whether the citizens of Crowley, Texas, desire to continue the Crime Control and Prevention District and to Continue a Crime Control and Prevention District Sales Tax; and

WHEREAS, on March 13, 2020, Governor Gregory Abbott certified that the novel coronavirus (COVID-19) posed an imminent threat of disaster and under the authority vested in the Governor by Section 418.014 of the Texas Government Code, declared a state of disaster for all counties in Texas; and

WHEREAS, pursuant to Section 418.016 of the Texas Government Code, on March 18, 2020, Governor Gregory Abbott signed a proclamation suspending certain provisions of the Texas Election Code to allow all local political subdivisions that are utilizing the May 2, 2020 uniform election date to postpone their elections to the November 3, 2020, uniform election date; and

WHEREAS, the Crowley Crime Control and Prevention District and the one-half (1/2) of one (1) percent sales tax is set to expire on September 30, 2020; and

WHEREAS, Section 41.0011 of the Texas Election Code allows for a Special Election to be held as an emergency election on a date other than a uniform election date if requested by the political subdivision and granted by the Governor of the State of Texas; and

WHEREAS, on April 3, 2020, the Crowley Crime Control and Prevent District Board Chairperson and City of Crowley Mayor requested to hold an Emergency Special Election on July 14, 2020 which was granted by Proclamation by Governor Gregory Abbott on April 6, 2020 attached hereto as Exhibit "A."

NOW, THEREFORE, IT IS ORDERED BY THE BOARD OF DIRECTORS OF THE CROWLEY CRIME CONTROL AND PREVENTION DISTRICT:

SECTION 1. REFERENDUM POSTPONED

The referendum called for Saturday, May 2, 2020, to submit to the voters a proposition to determine whether the crime control and prevention district and sales tax will be continued for a period

of 15 years is postponed to July 14, 2020 between the hours of 7:00 a.m. and 7:00 p.m.

SECTION 2. GOVERNING LAW AND NOTICE OF REFERENDUM

The referendum shall be held in accordance with the Texas Local Government Code, Texas Election Code, and City Charter. Notice of this referendum shall be given in accordance with the governing laws.

SECTION 3. TEXAS COMPTROLLER OF PUBLIC ACCOUNTS

Upon adoption of this Order, the City Secretary is directed to immediately give notice to the Texas Comptroller of Public Accounts, by delivering a copy of this Order via mail.

SECTION 4. NECESSARY ACTIONS

The Mayor and the City Secretary, in consultation with the City Attorney, are authorized and directed to take all actions necessary to comply with the provisions of the Election Code, the City Code and City Charter, and Chapter 327 of the Tax Code in carrying out and conducting the referendum, whether or not expressly authorized by this Order.

SECTION 5. EFFECTIVE DATE

This Order shall be effective upon its adoption.

PROCLAMATION BY THE Governor of the State of Texas

TO ALL TO WHOM THESE PRESENTS SHALL COME:

WHEREAS, on March 13, 2020, the Governor of Texas certified that the novel coronavirus (COVID-19) poses an imminent threat of disaster and, under the authority vested in the Governor by Section 418.014 of the Texas Government Code, declared a state of disaster for all counties in Texas; and

WHEREAS, the Commissioner of the Texas Department of State Health Services has determined that, as of March 19, 2020, COVID-19 represents a public health disaster within the meaning of Chapter 81 of the Texas Health and Safety Code; and

WHEREAS, also on March 19, 2020, and March 31, 2020, the Governor issued executive orders in accordance with the President's Coronavirus Guidelines for America, as promulgated by President Donald J. Trump and the Centers for Disease Control and Prevention, and mandated certain obligations for Texans that are recommended by federal guidelines and aimed at slowing the spread of COVID-19; and

WHEREAS, Section 41.001(a)(2) of the Texas Election Code provides that a general or special election in this state shall be held on a uniform election date, and the next uniform election date is occurring on May 2, 2020; and

WHEREAS, on March 18, 2020, the Governor suspended Sections 41.0052(a) and (b) of the Texas Election Code and Section 49.103 of the Texas Water Code to the extent necessary to allow political subdivisions that would otherwise hold elections on May 2, 2020, to move their general and special elections for 2020 only to the next uniform election date, occurring on November 3, 2020; and

WHEREAS, on March 20, 2020, the Governor issued a proclamation postponing the runoff primary election date to July 14, 2020, and early voting by personal appearance for the runoff primary election begins on July 6, 2020, in accordance with Section 85.001(b) of the Texas Election Code; and

WHEREAS, Section 41.007(d) of the Texas Election Code provides that no other election may be held on the date of a primary election; and

WHEREAS, Section 41.008 of the Texas Election Code provides that an election held on a date not permitted is void; and

WHEREAS, Section 85.001(a) of the Texas Election Code provides that the period for early voting by personal appearance begins on the 17th day before election day and continues through the fourth day before election day; and

WHEREAS, Section 363.251(a) of the Texas Local Government Code authorizes that a crime control and prevention district created by a political subdivision may hold a referendum on the question of whether to continue the district on the next uniform election date authorized by Section 41.001(a) of the Texas Election Code; and

WHEREAS, the Crowley Crime Control and Prevention District has ordered a special election on the question of whether to continue the district, and such election was scheduled for May 2, 2020; and

WHEREAS, Section 41.0011 of the Texas Election Code provides that a special election may be held as an emergency election before the appropriate uniform election date if a political subdivision asks the Governor for permission to do so and the Governor determines that an emergency exists; and

WHEREAS, the Crowley Crime Control and Prevention District desires to order a special election as an emergency election on the question of whether to continue the district pursuant to Section 41.0011 of the Texas Election Code and has asked the Governor for permission to hold such election prior to November 3, 2020; and

WHEREAS, an emergency exists under Section 41.0011 of the Texas Election Code due to the circumstances presented by the COVID-19 disaster and because the Crowley Crime Control and Prevention District is not able to wait until November 3, 2020, to hold a special election on the question of whether to continue the district; and

WHEREAS, pursuant to Section 418.016 of the Texas Government Code, the Governor has the express authority to suspend the provisions of any regulatory statute prescribing the procedures for conduct of state business or the orders or rules of a state agency if strict compliance with the provisions, orders, or rules would in any way prevent, hinder, or delay necessary action in coping with a disaster.

NOW, THEREFORE, I, GREG ABBOTT, Governor of Texas, under the authority vested in me by the Constitution and laws of the State of Texas, do hereby suspend Sections 41.007(d) and 41.008 of the Texas Election Code to the extent necessary to allow the Crowley Crime Control and Prevention District to order its special election to occur on July 14, 2020, as an emergency election on the question of whether to continue the district pursuant to Section 41.0011(b) of the Texas Election Code. I further suspend Section 85.001(a) of the Texas Election Code to the extent necessary to allow early voting by personal appearance for the special election to begin not earlier than Monday, July 6, 2020, and to run concurrently with the early voting period for the runoff primary election.

The authority ordering the election under Section 3.004 of the Texas Election Code is the authority authorized to make the decision to postpone its election in accordance with this proclamation.

Early voting by personal appearance shall begin on Monday, July 6, 2020, in accordance with Section 85.001(d) of the Texas Election Code so that it runs concurrently with the early voting period for the runoff primary election.
