BACKGROUND:

The Crowley Economic Development Corporation (CEDC) and Four Train Days Development, LLC entered into an Economic Development and Performance Agreement on January 19, 2023. Article 5 of the agreement outlines the obligations of the Developer. Having exceeded the required \$350,000 investment and assuming full responsibility for design and construction costs, the Developer originally leased the property to the restaurant El Chato's, which has since defaulted. The Developer is actively seeking a new tenant and has requested an extension of the certificate of occupancy deadline from June 30, 2024, to December 31, 2024, per Article 5.01(C) of the agreement. The Developer is committed to replacing El Chato's to safeguard the substantial investment made in the property.

RECOMMENDATION:

Staff recommends approval to extend the date to obtain a Certificate of Occupancy until December 31, 2024.
