

## **CISD Eagle Drive Discussion**





SUBJECT: Discuss and provide guidance to city staff on accessory building

regulations.

Last year, the city updated the accessory building regulations as part of the overall zoning code update. The new regulations state that the size of an accessory building cannot be larger than 30 percent of the floor area of the primary structure. This is a common type of regulation because accessory buildings are supposed to support the primary use and not replace or compete with it; accessory buildings should be clear subordinate to primary structures. Accessory buildings typically have lower design standards (in terms of both zoning and building codes) than primary structures, and accessory buildings that are too large may not be compatible with the overall development in the neighborhood. For example, these days we're seeing more permit applications for metal accessory buildings, which may not fit the design and look of the neighborhoods where they're located.

Cities typically ensure that accessory buildings are clearly subordinate to the primary structure by limiting their size, either by a percentage of the primary structure's floor area or by limits on total square footage. The current zoning code uses the percentage approach. The previous zoning code had a square footage limit of 320 square feet (detached garages and barns could be larger depending on the zoning district/lot size, but a regular accessory buildings could not be larger than 320 square feet).

The newer approach allows for larger accessory buildings for most of the homes in Crowley; 320 square feet is 30% of 1,066, so any home larger than 1,066 square feet is now allowed a larger accessory building than before, provided the total area of both the house and the accessory building still fall under the maximum lot coverage. Recently, we heard from a resident who is unhappy with the size limit. She would like to install an accessory building with a floor area of around 750 square feet, but because her house is small (around 1,250 square feet), that size is 60% of the floor area of the house.

Staff would like direction from Council on whether you would like to see changes to the ordinance regarding accessory buildings. Specifically, does the Council think the percentage requirement should be adjusted to allow for larger accessory buildings for smaller homes? Would you like to see the regulations changed but through a different approach? Or would you prefer the regulations to remain as written?

- (1) All accessory uses and structures shall be subject to the general standards in this section, as well as any applicable additional standards in Section 106.67(E), Additional Standards for Certain Accessory Uses and all standards applicable to the associated primary use as set forth in Section 106.66, Supplemental Use Standards.
- (2) Size: All accessory uses and structures shall:
  - a. Be clearly subordinate in area, extent, and purpose to the primary use or structure.
  - b. Not violate the bulk, density, parking, landscaping, or open space standards of this Chapter when taken together with the primary use or structure.
  - c. The floor area of any detached accessory structure shall not exceed 30 percent of the floor area of the primary structure. The total combined floor area of all structures shall not exceed the maximum lot coverage for the zoning district in which it is located. The Administrator may authorize a structure to exceed this percentage if the structure is used for a permitted agricultural use.
- (3) Function: All accessory uses and structures shall directly serve the primary use or structure, and be accessory and clearly incidental to the primary use or structure.
- (4) Timing: Accessory uses and structures shall not be constructed or established prior to the start of construction of the primary use or structure. An accessory structure shall not be used until the construction of the primary structure is complete.
- (5) Height: Accessory structures shall be limited to a maximum height of the existing principal structure on the lot or the maximum height permitted in the corresponding residential zoning district for residential accessory structures or 25 feet for all other zoning districts.
- (6) Location: Accessory uses or structures shall be located on the same lot as the primary use or structure and shall comply with setback standards in Section 106.67(E), Additional Standards for Certain Accessory Uses.
  - a. Accessory structures shall not be located within platted or recorded easements.
  - b. The Administrator may authorize an accessory structure on a vacant lot if the structure is used for animal or crop production associated with an agricultural use, or used in conjunction with a park/open space or community garden.

## (7) Design Compatibility:

- a. Except where exempted, all accessory structures shall be designed to be aesthetically compatible with the primary structure. Compatibility shall be evaluated in terms of building materials, building orientation, building placement, building articulations, and building mass. Non-enclosed stables, gazebos, greenhouses, and carports 10 feet or less in height with a roofed area of 120 square feet or less are exempt from this compatibility requirement.
- b. Applicants for accessory structures not exempted in accordance with this subsection who request exceptions from the design compatibility requirements shall demonstrate screening methods or design features that will be used to minimize any potential adverse effects on neighboring properties.
- (8) Ownership: Accessory uses or structures shall be owned or operated by the same person as the primary use or structure.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CROWLEY, TEXAS APPROVING AN ADVANCE FUNDING AGREEMENT WITH THE TEXAS DEPARTMENT OF TRANSPORTATION FOR THE DESIGN AND INSTALLATION OF THE GREEN RIBBON LANDSCAPE IMPROVEMENTS ON FM731 FROM SOUTH HAMPTON ROAD TO DEER CREEK DRIVE AND AUTHORIZING THE CITY MANAGER OR HIS DESIGNATED REPRESENTATIVE TO EXECUTE THE AGREEMENT; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS,** the City of Crowley (the "City" or "Local Government") is a home rule city acting under its charter adopted by the electorate pursuant to Article XI, Section 5, of the Texas Constitution and Chapter 9 of the Local Government Code; and

**WHEREAS**, the Texas Transportation Commission passed Minute Order 116292 that provides for the development of, and funding for, the landscape project described herein; and

**WHEREAS**, on September 16, 2022, the Texas Department of Transportation (the "State") approved the City of Crowley's proposed Green Ribbon Landscape improvement project on FM731 between South Hampton Road and Deer Creek Drive; and

**WHEREAS,** the City Council desires to enter into an Advance Funding Agreement with the Texas Department of Transportation for the design and installation of the Green Ribbon Landscape Improvements on FM731 from South Hampton Road to Deer Creek Drive, and to authorize the City Manager or his designated representative to execute the Advance Funding Agreement.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF CROWLEY, TEXAS:

### SECTION 1.

The City Manager or his designated representative is hereby authorized to execute the Advance Funding Agreement with the Texas Department of Transportation for the design and installation of the Green Ribbon Landscape Improvements on FM731 between South Hampton Road and Deer Creek Drive with the Local Government 100% responsible for environmental and engineering overruns and the State 100% responsible for any construction overruns."
